Liability & Indemnity Waiver

This Release and Waiver of Liability (the Release) executed on this _____ day of _____, by _____ (the Contestant) in favor of Boston Society of Architects/ Boston Foundation for Architecture, and the Common Boston Common Build 2011 Partners, their directors, officers, employees, and agents (collectively the "Releasees").

The Contestant desires to compete in the Common Boston Common Build 2011 an event organized by the Releasees, and engage in the activities related to being a contestant (the Activities). The Contestant understands that the Activities may include building structures in and around residential and commercial buildings. The Contestant hereby freely, voluntarily and without duress executes this Release under the following terms:

Release and Waiver. Contestant does hereby release and forever discharge and hold harmless the Releasee and their successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with the Releasees.

Contestant understands that this Release discharges the Releasees from any liability or claim that the Contestant may have against the Releasees with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Contestant's Activities with the Releasees, whether caused by the negligence of the Releasees or its officers, directors, employees, or agents or otherwise. Contestant also understands that the Releasees do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

It is the policy of the Releasees that persons under the age of 18 not be allowed to enter the Common Boston Common Build competition without the consent of a legal guardian.

Medical Treatment: Contestant does hereby release and forever discharge the Releasees from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Contestant's Activities with the Releasees or with the decision by any representative or agent of the Releasees to exercise the power to consent to medical or dental treatment.

Assumption of Risk: Contestant understands that the Activities include work that may be hazardous (that is, that can cause serious physical injury or death) to the Contestant, including but not limited to, construction, loading and unloading, and transportation to and from the work sites. Contestant agrees to work with full knowledge of the dangers and potential injuries involved. Contestant hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases the Releasees from all liability for injury, illness, death, or property damage resulting from the Activities and/or Contestant's negligence. Contestant also agrees to indemnify the Releasees for any injury they cause another.

Insurance: Contestant understands that, except as otherwise agreed to by the Releasees in writing, the Releasees do not carry or maintain health, medical or disability insurance covered for any Contestant. Each Contestant is expected and encouraged to obtain his or her own medical or health insurance coverage.

Photographic Release: Contestant does hereby grant and convey onto the Releasees all right, title, and interest in any and all photographic images and video or audio recordings made by the Releasees during the Contestant's Activities with the Releasees, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other: Contestant expressly agrees that this Release is intended to be as broad and inclusive as permitted by applicable state and federal laws where such Activities are located. Contestant agrees that if there is any dispute with the Releasees, it will be resolved by binding arbitration in the state where such Activities are located, based upon the rules of the American Arbitration Association and state law. Contestants agrees that in the event that any clause or provisions of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

This Liability Waiver and Indemnity is binding on me, my parents, my heirs, agents, personal representatives, successors, assigns, and other persons acting or purporting to act on my behalf.
